Through five earlier volumes, *Inherit the Earth*, *Architects of Emortality*, *The Fountains of Youth*, *The Cassandra Complex*, and *Dark Ararat*, Stableford has mapped out for us in engaging stories the wonderful and sometimes disturbing world of the next thousand years, on Earth, throughout the solar system, and to worlds beyond, with emphasis on huge sociological changes and extraordinary alterations in the biological life of humans. It is one of the most detailed and plausible and fascinating projections in all of science fiction. Haarr then focuses on the British landings in Central Norway, where the Royal Navy first had its mastery challenged by air superiority from land-based aircraft. Next, he examines the events in and around Narvik where Allied naval, air and land forces were engaged in the first combined amphibious landings of World War II. Finally, Haarr sums up the the evacuation in June, in which the first carrier task force operations of the war, including the loss of the HMS *Glorious*, figure prominently. As Haarr's previous volume, *The Gathering Storm*, the narration shifts between strategic and operational issues, and the experiences of the officers and soldiers on the frontlines. Extensive research and use of primary sources reveal the many sides of this battle, some of which remain

controversial to this day.

In 1806, U.S. Army General James Wilkinson assigned Lieutenant Zebulon Montgomery Pike to explore the headwaters of the Arkansas and Red rivers. From St. Louis, the lieutenant's modest party traveled across the Great Plains to the Front Range of the Rocky Mountains. Throughout the journey, Pike maintained a journal, describing terrain, Indians, hardships, and the group's daily activities. In present-day southern Colorado's San Luis Valley, Pike and his men were captured by the Spanish and taken to Santa Fe, where many of his papers were confiscated by Spanish authorities, not to be uncovered until the early twentieth century. Pike was taken south by the Spanish to Chihuahua, Mexico. Along the route, he was a keen observer of Spanish settlements, military strength, commerce, natural resources, Indian tribes, and more. Finally, the Spanish governor had Pike and his party escorted through Texas, to Natchitoches, Louisiana, where they arrived on July 1, 1807. This valuable and long-out-of-print edition of Pike's Southwestern journals is being reissued on the bicentennial of the journey. Editors Hart and Hulbert provide extensive commentary to the journals, as well as significant essays on Pike's papers and the purpose of his famed expedition. Mark L. Prominent Elizabethans assisted Gilbert by researching and investing in his expedition: the Printing Revolution was critical to their plans, as Gilbert's supporters traveled throughout England with promotional literature proving England's claim to North America. Gilbert's experts used maps and charts to publicize and navigate, while his pilots experimented with new navigating tools and practices. Though he failed to establish a settlement, Gilbert created a blueprint for later Stuart colonizers who achieved his vision of a British Empire in the Western Hemisphere. This book clarifies the role of cartography, natural science, and promotional literature in Elizabethan colonization and elucidates the preparation stages of early modern colonizing voyages.

Two hundred and fifty years ago Captain James Cook, during his extraordinary voyages of navigation and maritime exploration, searched for Antarctica – the Unknown Southern Continent. Throughout the narrative Cook's exceptional seamanship and navigational skills, and that of his crew, are displayed during often-difficult passages in foul weather across uncharted and inhospitable seas.
